

Rubicon Organics Detailed Voting Results of the Annual General and Special Meeting

VANCOUVER, BRITISH COLUMBIA, August 4, 2024 – Rubicon Organics Inc. (TSXV: ROMJ) (OTCQX: ROMJF) ("Rubicon Organics" or the "Company"), a licensed producer focused on cultivating and selling organic certified and premium cannabis, reports the voting results from its Annual General and Special Meeting of shareholders (the "Meeting") held earlier today.

A total of 40,039,174 shares were represented in person or by proxy at the Meeting, constituting approximately 71% shares represented of the Company's total issued and outstanding Common shares as of the record date, and voted in favour of all matters brought before the Meeting.
